KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, J. B. Belin, Jr. ("Developer") as Trustee, did by instrument recorded in Volume 442 at Page 225 of the Deed Records of Leon County, Texas, impose certain Reservations, Restrictions and Covenants ("Restrictions") upon HILLTOP LAKES SECTION 82 (the "Subdivision") a subdivision in Leon County, Texas, according to the plat thereof recorded in Volume 4 at Page 44 of the Map Records of said county; and,

WHEREAS, the Developer wishes to alter and amend the Restrictions to further enhance the value of the lots in the Subdivision:

NOW, THEREFORE, BE IT KNOWN THAT the aforesaid Restrictions are hereby

amended as follows:

1. All of the present Section 3 relating to the use of such lots for the purpose of installing Mobile Homes or constructing Cottages is deleted in its entirety and the following is substituted therefor:

No dwelling or residence shall be erected on any lot or the plans approved therefor having a living area of less than 950 square feet in all blocks in section. The foregoing square footage is exclusive of porches, breezeways, garages and other appendages.

The exterior material of the main dwelling or residence on any lot or plat shall be not less than 55% brick, stone or its equivalent. This ratio may be changed with written approval of the Architectural Control Committee as set out in these restrictions for special design effects, etc. Foundations to be of a concrete slab type, or if special foundations are needed due to terrain or design, such foundation must be approved in writing by the Architectural Control Committee as herein provided. All improvements or additions shall be substantially and safely constructed, painted and kept in good repair, and all lots shall be kept in clean and sanitary condition.

2. All of Section 36 - Special Restrictions - Mobil Homes is deleted.

3. All of Section 37 - Special Restrictions - Cottages is deleted.

4. Sections 38 - Enforcement, Section 39 - Effect of Violations on Mortgages and Section 40 - Partial Invalidity are hereby renumbered as Sections 36, 37, and 38, respectively.

Except as set forth herein, the above described restrictions shall remain in full force and effect binding on the Subdivision according to their terms.
